Transition House families are grateful for your belief in their strength to rebuild—and so are we!

Dear Friends,

In 2025, eighty-three local families lost their housing and became homeless—but they also found Transition House.

Each family’s path to homelessness was different. One parent left her job to care for a terminally ill family member and, in doing so, lost her home. Another had been renting a room without a lease and was suddenly asked to leave, with nowhere to go. One father lost housing after his wife was detained by immigration and he could no longer afford the rent on his income alone.

While their stories are unique, they share a common thread: the absence of savings or a safety net to carry them through a financial crisis.

Because of you, that changed.

Through your support of Transition House—as a donor, a volunteer, or both—you became the safety net these families needed. You gave them something invaluable: time. Time to return to work, to save, and to prepare for a stable future in an apartment of their own.

When families arrive at Transition House, we ask what they hope to achieve during their stay. Their answers are simple and powerful: to save money, to pay their bills independently, and to provide a safe, stable place for their children to grow. At their core, these goals reflect something deeper—the desire to regain independence and dignity. And that is exactly what your support makes possible.

In 2025, 74% of the families who left our shelter moved into housing with the income, skills, and resources needed to sustain it. They also began building safety nets of their own—setting monthly savings goals and gaining a stronger understanding of community resources they can rely on in the future.

But while they were at Transition House, you were that safety net.

And it worked!

31 FAMILIES IN TRANSITIONAL HOUSING

THE IMPACT YOU HAD

74% MOVED TO HOUSING

Because of you, the majority of shelter families succeeded in transitioning to stable rental housing. While at our shelter, families work with their case managers to plan for their return to housing and received support locating places to rent.

87% EMPLOYED

Parents participated in employment skills workshops, and identified career goals and areas for advancement that fit their skills and interests. They also received help searching for employment. With your support, parents gained or maintained a job, and improved their income while in the program.

\$2,837 IN SAVINGS

You helped families build their safety net. On average, shelter families saved \$2,837 towards move-in costs.

141 ATTENDED CLASSES

Your support allowed us to offer free anti-poverty classes with childcare to 141 adults from all of our programs plus low-income members of the community.
